#### Investment in an Asian Credit Fund

Nippon Life Insurance Company (President: Yoshinobu Tsutsui; hereinafter "Nippon Life") would like to announce the completion of an investment of USD 93 million in an Asian credit fund managed by Schroder Investment Management (Singapore) Ltd (hereinafter "Schroder IM").

Schroder IM is a wholly owned subsidiary of Schroders plc (hereinafter "Schroders"), which is one of the world's largest asset management firms and has lengthy investment experience in a wide variety of assets including fixed income. Schroders and Nippon Life have a longstanding amicable relationship which includes joint venture companies in London and Singapore.

Schroder IM's fund targets investment in Asian investment grade corporate bonds for which the market is rapidly expanding today. When initiating an investment, the manager not only considers the risk-return profile of an issuer but also aspects that could have a material impact on an issuers' credit profile, such as environmental, social or governance factors.

Nippon Life has hitherto focused mainly on investing in ESG( $\circledast$ ) related areas in Europe such as green bonds issued by the City of Paris and environmentally friendly bonds issued by Transport for London. A credit fund targeting Asian countries which takes similar aspects into consideration is rare and constitutes our first effort in this area.

The establishment of this fund will be one of our investments in the three-year business plan, in which we target a total investment of JPY 1 trillion in "new and emerging growth fields" over a span of three to five years. Through this investment, we wish to further enhance our investment capabilities and push forward our investment in ESG-related areas.
